(NEATH ABBEY ROAD AND ROMAN WAY, NEATH ABBEY, NEATH)
(LIMITED WAITING) (ONE WAY TRAFFIC) AND (NO ENTRY)

ORDER 2012

The Neath Port Talbot County Borough Council in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order: -

1. This Order shall come into force on the 28th day of November 2012 and may be cited as the "Neath Port Talbot County Borough Council (Neath Abbey Road and Roman Way, Neath Abbey, Neath) (Limited Waiting) (One Way Traffic) and (No Entry) Order 2012".
2. (1) In this Order –
 - "Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;
 - "Disabled Person's Badge" has the same meaning as in The Disabled Person's (Badges for Motor Vehicles) (Wales) Regulations 2000;
 - "Parking Disc" means a parking disc issued by a Local Authority, capable of showing the quarter hour period during which a period of waiting begins;
 - "Relevant Position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;
 - "Public Service Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;
 - "Universal Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000;
 - "Mechanical Cleansing Vehicle" shall mean a street/drain cleaning vehicle owned by or contracted to the Neath Port Talbot County Borough Council.
- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. Save as provided in Articles, 4, 5, 6 and 7 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait for more than 20 minutes or to return within 40 minutes to the same length of side of road on which that period waiting began on any day except Saturday and Sunday between the hours of 8.00am and 6.00pm on the lengths of sides of road set out in Schedule 1 of this Order.
4. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait on the length of side of road specified therein for so long as may be necessary to enable: -
- (A) A person to board or alight from a vehicle;
 - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely: -
 - (i) Building, industrial or demolition operations;
 - (ii) The removal of any obstruction to traffic;
 - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
 - (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
 - (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
 - (E) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
 - (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.

5. Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait on the length of side of road specified therein for so long as may be necessary to enable goods to be loaded and unloaded from the vehicle.
6. The prohibitions imposed by Article 3 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.
7. Nothing in Article 3 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait on the lengths of sides of roads referred to in the said Article.
8. Save as provided in Article 9 of this Order no person shall cause or permit any vehicle to proceed along the length of road set out in Schedule 2 of this Order other than in the direction specified therein.
9. Nothing in Article 8 of this Order shall apply to a Mechanical Cleansing Vehicle whilst engaged in any street/drain cleaning operations on behalf of the Neath Port Talbot County Borough Council.
11. No person shall cause or permit any vehicle to enter those roads specified in Schedule 3 of this Order at the points set out in that Schedule.

SCHEDULES

Schedule 1 – Waiting Limited to 20 minutes, Return Prohibited within 40 minutes, 8am-6pm, Monday - Friday **Neath Abbey Road, Neath Abbey (South Side)**

- 1.1 From a point approximately 11 metres south west of its junction with Roman Way for a distance of approximately 88 metres in a south westerly direction.

Schedule 2 – One Way Traffic **Roman Way, Neath Abbey**

- 2.1 From a point approximately 23 metres south east of its junction with Neath Abbey Road for a distance of approximately 484 metres in a clockwise direction.

Schedule 3 – Prohibition of Entry **Roman Way, Neath Abbey**

- 3.1 Prohibition of entry for vehicular traffic travelling in a south westerly direction on Roman Way at a point approximately 25 metres south east of its junction with Neath Abbey Road.
- 3.2 Prohibition of Entry for vehicular traffic travelling in a southerly direction on Roman Way at its junction with Glynleiros Gardens.
