**(NEATH TRAFFIC MANAGEMENT REVIEW - PHASE 3)**

**ORDER 2004**

**THE NEATH PORT TALBOT COUNTY BOROUGH COUNCIL** in exercise of its powers under Sections 1, 2, 32, 35, 45, 46, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "The Act of 1984") and of all other powers it enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order:-

1. The Order shall come into operation on the 20 day of December 2004 and may be cited as the "Neath Port Talbot County Borough Council (NEATH TRAFFIC MANAGEMENT REVIEW - PHASE 3) ORDER 2004

2. (1) In this Order –

"Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;

"Disabled Person's Badge" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;

"Parking Disc" means a parking disc issued by a Local Authority, capable of showing the quarter hour period during which a period of waiting begins;

"Relevant Position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000;

"Public Services Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;

“Universal Service Providers” means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000;

“Disabled Parking Place” means an area of highway designated as a parking place by Schedule 13 of this Order for use by Disabled Persons Vehicles;

“Residents Parking Place” means an area of highway designated as a Parking Place by this Order for the use of vehicles displaying on the front or nearside of the vehicle a valid Residents Parking Place Permit;

“Residents Parking Place Permit” (hereinafter referred to as a “Permit”) means a Permit issued by the Council for a period of up to 12 months to a person who has satisfied the Council as being entitled to the issue of a Residents Permit in accordance with the Council’s policy as may be determined from time to time;

“Disabled Residents Parking Place” means an area of highway designated as a Parking Place by this Order for the use of a vehicle displaying on or beneath the front windscreen of the vehicle a valid Disabled Residents Parking Place Permit issued in respect of that particular parking place

“Disabled Residents Parking Place Permit” (hereinafter referred to as a “Disabled Residents Permit”) means a permit issued by the Council for a period of up to 12 months to a person who has satisfied the Council as being entitled to the issue of a permit in accordance with the Council’s policy for the issue of such permits as may be determined from time to time.

- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
  - (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. The provisions of the Orders specified in Schedule 1 of this Order are hereby revoked insofar as they relate to the lengths of sides of roads specified in Schedules 2 to 12 (inclusive) and 15,16,17 of this Order.

4. Save as provided in Articles 18 and 20 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait, load or unload on any days except Sunday between the hours of 10:30 am and 5:00 pm on the lengths of sides of roads set out in Schedule 2 of this Order.
5. Save as provided in Articles 18, 19, 20 and 21 of this Order, no person except at the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait on any days except Sunday between the hours of 5:00 pm and 10:30 am on the sides of lengths of roads set out in Schedule 2 of this Order.
6. Save as provided in Articles 18 and 20 of this Order, no person except on the direction of Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait, load or unload at anytime on the lengths of sides of roads set out in Schedule 3 of this Order.
7. Save as provided in Articles 18, 19, 20 and 21 of this Order no person except at the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait at anytime on the lengths of sides of roads set out in Schedule 4 of this Order.
8. Save as provided in Articles 18, 19, 20 and 22 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait for more than 1 hour or to return within 2 hours to the same length of side of road on which that period of waiting began on any day except Sunday between the hours of 8:00 am and 6:00 pm on the lengths of sides of road set out in Schedule 5 of this Order.
9. Save as provided in Articles 18, 19, 20 and 22 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait for more than 2 hours or to return within 4 hours to the same length of side road on which that period of waiting began on any day except Sunday between the hours of 8:00 am and 6:00 pm on the lengths of sides of road set out in Schedule 6 of this Order.
10. (1) Save as provided in Articles 10(2), 18, 19, 20 and 22 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait for more than 1 hour or to return within 2 hours to the same length of side of road on which that period of waiting began on any day except Sunday between the hours of 8:00 am and 6:00 pm on the lengths of sides of road set out in Schedule 7 of this Order.

- (2) The prohibition imposed by Article 10(1) above shall not apply to the holder of a Residents Permit.
- 11. (1) Save as provided in Articles 11(2), 18, 19, 20 and 22 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait for more than 30 minutes or to return within 1 hour to the same length of side of road on which that period of waiting began on any day except Sunday between the hours of 8:00 am and 6:00 pm on the lengths of sides of road set out in Schedule 8 of this Order.
- (2) The prohibition imposed by Article 11(1) above shall not apply to the holder of a Residents Permit.

**12. Disabled Residents Parking Places**

- (1) Except as provided by Articles 12(2), 18, 19 and 20 of this Order or upon the direction or with the permission of a Police Constable in uniform or a Parking Attendant no person shall cause or permit any vehicle to park in the Disabled Residents Parking Place designated by Schedule 11 to this Order.
- (2) The provisions of Article 12(1) to this Order shall not apply to the holder of a Disabled Residents Permit when parking a vehicle in a Disabled Residents Parking Place as described in Schedule 11 to this Order and the vehicle is displaying a valid Disabled Residents Permit on or beneath the front windscreen of that vehicle in such a position that the front of the Permit and the written details thereon are clearly visible from outside the vehicle.

**13. Residents Parking Places**

- (1) Except as provided by Articles 13(2), 18, 19 and 20 of this Order or upon the direction or with the permission of a Police Constable in uniform or a Parking Attendant no person shall cause or permit any vehicle to wait in a Residents Parking Place designated by Schedule 9 to this Order.
- (2) The provisions of Article 13(1) to this Order shall not apply to the holder of a Residents Permit when parking a vehicle in a Residents Parking Place as described in Schedule 9 to this Order and the vehicle is displaying a valid Residents Permit (on the front or nearside of the vehicle)

**14. Regulation of Residents or Disabled Residents Parking Place**

- A.
- (i) The holder of a Residents or Disabled Residents Permit (hereinafter referred to as a "Permit") shall not park in any Parking Place other than one identified on the Permit;
  - (ii) where a Police Constable in uniform or a Parking Attendant is of the opinion that the provisions contained in Articles 12(1) or 13(1) of this Order have been contravened he may remove or cause to be removed the vehicle from the Parking Place and where it is so removed shall provide for the safe custody of the vehicle;
  - (iii) a Police Constable in uniform or a Parking Attendant may move or cause to be moved in the case of emergency to any place he thinks fit any vehicle left in the Parking Place;
  - (iv) the Permit shall be valid only for the vehicle in respect of which it is issued and no permit holder shall cause or permit any Permit issued to him by the Council to be displayed on any vehicle bearing a different registration number to that contained on that Permit;
  - (v) every vehicle in the Parking Place shall stop so that every part of the vehicle is within the limits of the Parking Place.
- B. A Police Constable in uniform or a Parking Attendant or a person duly authorised by the Council may suspend the use of the Parking Place or any part thereof whenever he considers such suspension is reasonably necessary:-
- (i) for the purposes of facilitating the movement of traffic or promoting its safety;
  - (ii) for the purposes of any building operation, the maintenance, improvement or reconstruction of the highway, or the cleansing of gullies in or adjacent to the Parking Place, the laying, erection, alteration or repair in or adjacent to the Parking Place of any sewer or of any main pipe or apparatus for the supply of gas, water, or electricity or of any telegraphic line or the placing maintenance or removal of any traffic sign;

- (iii) for the convenience of occupiers of premises adjacent to the Parking Place on any occasion of the delivery or removal of furniture to or from any office or dwelling house adjacent to the Parking Place;
  - (iv) on any occasion on which it is likely by reason of some special attraction that any streets will be thronged or obstructed;
  - (v) for the convenience of occupiers of premises adjacent to the Parking Place at times of weddings or funerals;
  - (vi) any person or Police Constable in uniform or a Parking Attendant suspending the use of the Parking Place or any part thereof, in accordance with the provisions of this Article shall thereupon place or cause to be placed in that Parking Place or as the case may be that part thereof the use of which is suspended a traffic sign of any size, colour and type prescribed or authorised under Section 64 of the Act of 1984 indicating that the waiting by vehicles is prohibited.
- C. No person shall cause or permit any vehicle to wait in any part of the Parking Place during such period as there is in or adjacent to that part of the Parking Place a traffic sign placed in pursuance of Paragraph B(vi) of this Article.

Provided that nothing in this Article shall apply: -

- (i) in respect of any vehicle being used for fire brigade, ambulance or police purposes or any vehicle which is waiting for any other reason specified in this Order;
  - (ii) to anything done with the permission of a Police Constable in uniform, Parking Attendant or the person suspending the use of the Parking Place or part thereof in pursuance of this Order.
- D. Nothing in Articles 12(1) or 13(1) of this Order shall apply to: -
- (a) legally qualified medical practitioners as defined in Section 52 of the Medical Act 1956, community nurses or registered veterinary surgeons while visiting premises adjacent to the Parking Place provided that the vehicle is displaying an appropriate worded notice to the effect that it is being used "on call";

- (b) a maximum of two vehicles being used in connection with a wedding;
- (c) vehicles being used for building and maintenance purposes in properties adjacent to a Parking Place;
- (d) to enable any hearse or any vehicle owned by a funeral director or owner of funeral vehicles to be used as part of a funeral cortege or otherwise in connection with a funeral;
- (e) to enable Support Officers of a bona fide care organisation to park in the Parking Place whilst visiting a Community Care dwelling in pursuit of their duties, providing the special permit issued by the Council is displayed in the correct position on the front windscreen of their vehicle.

### **Permits**

- E. (i) The Council may at any time require an applicant for a Permit or the holder of a Permit to produce to an Officer of the Council such evidence in respect of an application for a Permit made to them as they may reasonably require to verify any particulars or information given to them or in respect of any Permit issued by them as they may reasonably require to verify that the Permit is valid;
- (ii) On receipt of an application for a Permit the Council upon being satisfied that: -
  - (a) the applicant is a person who resides in a road referred to in Schedules 7, 8, 9 and 11 of this Order or is a person who falls within the categories of persons eligible for the granting of a Permit as may be determined from time to time by the Council;
  - (b) the application is made in respect of an eligible vehicle as defined in paragraph E (iii) of this Article;

shall issue to the applicant a Permit in respect of that vehicle, subject to no more than two Permits being issued in respect of any particular residence.

- (iii) For the purposes of this Article “eligible vehicle” means: -

- (a) a passenger vehicle which is a motor vehicle constructed solely for the carriage of passengers and their effects and adapted to carry not more than twelve passengers exclusive of the driver and not drawing a trailer;
  - (b) solo motor cycle or moped.
- (iv)
  - (a) No person shall be entitled to hold a Permit for more than one vehicle at any one time;
  - (b) The Permit shall be valid only for the vehicle in respect of which it is issued and no permit holder shall cause or permit any Permit issued to him by the Council to be displayed on any vehicle bearing a different registration number to that contained on that Permit.
- (v) A permit holder may surrender a Permit to the Council at any time and shall surrender it to the Council on the occurrence of any one of the following events: -
  - (a) the permit holder ceasing to be a resident in the street for which the Permit was issued;
  - (b) save as provided in paragraph E (viii)(a) of this Article the permit holder ceasing to be the owner of the vehicle in respect of which the Permit was issued;
  - (c) the vehicle in respect of which the Permit was issued being adapted or used in such a manner that it ceases to be an eligible vehicle as defined in paragraph E (iii) of this Article;
  - (d) the issue by the Council of a duplicate Permit;
  - (e) the expiry of the Permit pursuant to paragraph E (vi) of this Article;
  - (f) the withdrawal of the Permit by the Council.
- (vi) A Permit shall cease to be valid at the expiration of the date stated thereon or on the occurrence of any of the events set out in paragraph E (v) of this Article whichever is the earlier.

- (vii) The Council may by notice in writing served on a permit holder by sending the same by recorded delivery service to the permit holder at the address shown by that person on the application for the Permit or at any other address believed to be that person's abode withdraw a Permit if it appears to the Council that any of the events set out in paragraph E (v) of this Article has occurred and the permit holder shall surrender the Permit to the Council within forty eight hours of the receipt of the aforementioned notice.
- (viii) A Permit shall be in writing and shall include the following particulars: -
  - (a) the registration mark of the vehicle in respect of which the Permit was issued except when such Permit is issued to a resident whose vehicle is owned by a bona fide motor trader and in such cases the registration mark will be replaced with the words "MOTOR TRADER";
  - (b) the expiry date of the Permit pursuant to paragraph E (vi) of this Article;
  - (c) an indication that the Permit was issued by the Council;
  - (d) the name of the street in which the applicant resides.

### **Charges**

- F. (i) The issue of a Permit, shall be subject to the successful applicant for a Permit paying a charge of £10.00 to the Council for the issue and use of the Permit, such payment to be paid to the Council prior to the issue of the Permit.
  - (ii) In the event that a permit holder requires a duplicate Permit to replace a Permit which has been lost or destroyed, the issue of such a Permit shall be subject to a fee of £5.00 being paid to the Council prior to the issue of the duplicate Permit.
15. (1) The Loading Bay set out in Schedule 10 of this Order is designated as a parking place between the hours of 8:00 am and 6:00 pm on any day except Sunday for vehicles which are being loaded or unloaded only subject to the proviso that any such vehicle using the Loading Bay for the purpose of loading or unloading shall not remain in the Loading Bay for more than 30 minutes duration at any given time.

- (2) Save as provided by Articles 18 and 20 of this order no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle (including a Disabled Persons Vehicle) to use the Loading Bay referred to in Article 15(1) above other than for the purposes of loading or unloading vehicles subject to the proviso specified in that Article.
16. Save as provided by Articles 18, 19 and 20 of this order or upon direction or permission of a Police Constable in uniform or a Parking Attendant, no person shall cause or permit any vehicle to park in the Disabled Parking Place designated in Schedule 13 of this Order on any day except Sunday between the hours of 8:00 am and 6:00 pm unless that vehicle is a Disabled Person's Vehicle which displays in the relevant position a Disabled Persons Badge.
- 17.(1) Save as provided in Articles 17(2), 17(3) and 20 of this Order no person shall cause or permit any vehicle weighing in excess of 7.5 tonnes to proceed or be driven at anytime across that length of road set out in Schedule 12 of this Order.
- (2) The prohibition imposed by Article 17(1) above shall not apply to any person who intends to load or unload a vehicle adjacent to any premises situated on that length of road set out in Schedule 12 or adjacent to any premises which can only be accessed via that road by such a vehicle.
- (3) The prohibition imposed by Article 17(1) above shall not apply to a Mechanical Cleansing Vehicle whilst it is engaged in street/drain cleaning operations on behalf of the Neath Port Talbot County Borough Council.
18. Nothing in Articles 4, 5, 6, 7, 8, 9, 10(1), 11(1), 12, 13, 15(1) and 16 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable: -
- (A) A person to board or alight from a vehicle;
- (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations namely: -
- (i) Building, industrial or demolition operations;

- (ii) The removal of any obstruction to traffic;
  - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
- (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
- (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
- (E) Public Services Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
- (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
19. Nothing in Articles 5, 7, 8, 9, 10(1), 11(1), 12, 13 and 16 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable goods to be loaded and unloaded from the vehicle.
20. The prohibitions imposed by Articles 4, 5, 6, 7, 8, 9, 10(1), 11(1), 12, 13, 15(1), 16 and 17(1) of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.
21. Nothing in Articles 5 and 7 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a Disabled Person's Badge and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the lengths of sides of roads referred to in the Article for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same length of side of road on which that vehicle had previously been waiting).

22. Nothing in Articles 8, 9, 10(1) and 11(1) of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait on the lengths of sides of roads referred to in the said Article.
- 23.(1) Save as provided in Articles 23(2) of this Order no person shall cause or permit any vehicle to proceed along the length of road set out in Schedule 14 of this Order other than in the direction specified therein.
- (2) Nothing in Article 23(1) above shall apply to a Mechanical Cleansing Vehicle whilst engaged in any street/drain cleaning operations on behalf of the Neath Port Talbot County Borough Council.

**Schedule 2 – No Waiting. Loading or Unloading Monday to Saturday 10.30 am to 5.00 pm and No Waiting Monday to Saturday 5.00 pm to 10.30 am**

- i) Queen Street  
From its junction with Green Street to its junction with Orchard Street, a distance of approximately 190 metres.
- ii) Green Street  
From its junction with Windsor Road to its junction with The Square, a distance of approximately 150 metres.
- iii) The Square  
From its junction with Green Street to its junction with Wind Street and from its junction with New Street to its junction with Orchard Street a distance of approximately 20 metres.
- iv) Wind Street  
From its junction with Old Market Street to its junction with The Square a distance of approximately 100 metres.
- v) Church Place  
From its junction with Wind Street to its junction with New Street a distance of approximately 160 metres.
- vi) New Street  
From its junction with The Parade to its junction with The Square a distance of approximately 70 metres.
- vii) The Parade  
From its junction with Croft Road to its junction with New Street a distance of approximately 30 metres.
- viii) Angel Street  
From its junction with The Parade to its junction with Croft Road a distance of approximately 100 metres.

ix) Cattle Street

From its junction with Angel Street to its junction with Old Market Street a distance of approximately 115 metres.

**Schedule 3 - No Waiting, Loading or Unloading At Anytime**

1. Lower Windsor Road - North Side  
A distance of approximately 35 metres to cover the turning area of Lower Windsor Road.
2. Commercial Street
  - i) East Side  
From a point inline with the junction of Cribb's Row a distance of approximately 45 metres in a southerly direction.
  - ii) West Side  
From its junction with Cribb's Row for a distance of approximately 8 metres in a southerly direction, and between points approximately 35 metres and 46 metres south of its junction with Cribb's Row.
3. Cribb's Row – South Side  
From its junction with Commercial Street for a distance of approximately 8 metres in a westerly direction.
4. Rosser Street – South West Side  
Between points approximately 9 metres and 72 metres south east of the Southern kerbline of High Street (East).
5. Bridge Street – North Side  
From its junction with Brickyard Cottages for a distance of approximately 18 metres in an easterly direction and a distance of approximately 20 metres to cover the mini roundabout.
6. Castle Street – South Side  
From its junction with Prince of Wales Drive for a distance of approximately 25 metres in a westerly direction.
7. Arthur Street – North Side  
Between points approximately 9 metres and 18 metres east of its junction with London Road.

8. Old Market Street – West Side  
Between points approximately 10 metres and 16 metres North of the Southern kerbline of Wind Street

**Schedule 4 – No Waiting At Anytime**

1. Commercial Street – West Side  
Between points approximately 46 metres and 51 metres south of its junction with Cribb's Row.
2. Geoffrey Street – North Side  
Between points approximately 29 metres and 33 metres east of its junction with London Road.
3. Riverside Drive – South Side  
From its junction with Safeway Access Road for a distance of approximately 65 metres in an easterly direction.

**Schedule 5 – Waiting Limited to 1 hour, return prohibited within 2 hours  
Monday to Saturday, 8.00 am to 6.00 pm**

1. Orchard Street – West Side  
Between points approximately 46 metres and 73 metres south of its junction of the southern kerbline of The Square.
2. Lower Windsor Road (cul-de-sac) – West Side  
Between points approximately 8 metres and 41 metres north of the northern kerbline of the Access Road to the B4287.

**Schedule 6 – Waiting Limited to 2 hours, return prohibited within 4  
hours Monday to Saturday, 8.00 am to 6.00 pm**

1. Bridge Street – North Side  
Between points approximately 18 metres and 55 metres east of its junction with Brickyard Cottages.

**Schedule 7 – Waiting Limited to 1 hour return prohibited within 2 hours  
Monday to Saturday, 8.00 am to 6.00 pm**  
**Permit Holders Exempt**

1. Commercial Street – West Side  
Between points approximately 8 metres and 18 metres and 26 metres and 35 metres south of its junction with Cribb's Row.

2. Allister Street – North Side  
Between points approximately 14 metres and 25 metres east of its junction with Windsor Road.
3. Creswell Road
  - i) North Side  
Between points approximately 27 metres and 54 metres and 66 metres and 101 metres west of its junction with Victoria Gardens.
  - ii) South Side  
Between points approximately 43 metres and 93 metres west of its junction with Victoria Gardens.
4. Elias Street – North Side  
Between points approximately 48 metres and 71 metres west of its junction with Windsor Road.
5. Castle View – East Side
