# WEST GLAMORGAN COUNTY COUNCIL

# (ORCHARD STREET & GREENWAY ROAD, NEATH)

# (PROHIBITION OF WAITING, LOADING/UNLOADING, ENTRY,

### AND WEIGHT RESTRICTION) AND (REVOCATION) ORDER 1987

The West Glamorgan County Council in exercise of its powers as contained in Sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act of 1984") and of all other powers them enabling, and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:

 The Order may be cited as the West Glamorgan County Council (Orchard Street & Greenway Road, Neath) (Prohibition of Waiting, Loading/Unloading, Entry and Weight Restriction) and (Revocation) Order 1987 and shall come into operation on the 14th day of February 1987.

2. In this Order:

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1975;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1975;

"parking disc" means a disc, issued by a Local Authority, complying with the requirements of the British Standard Specification for Parking Discs (BS. No. 4631 - 1970), coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, and

"relevant position" means:-

- (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the nearside of an immediately behind the windscreen;
- (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or nearside of the vehicle.

"Public Service Vehicle" has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981. ... ... 2.

- The provisions of the following Orders or Schedules thereof as specified below are hereby revoked in so far as they relate or affect the sides or lengths of road as set out in the Schedules to this Order:-
- The West Glamorgan County Council (Various Streets, Neath) (Public Service Vehicle Stands) Order 1975 made on 31st July 1975

The West Glamorgan County Council (Various Streets, Neath) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 1976 made on 17th March 1976 in respect of Schedules 1, 2 and 4 thereof.

The West Glamorgan County Council (Orchard Street, Neath, Queen Street, Green Street, Wind Street and New Street, Neath) (Limited Access) Order 1976 made on 19th July 1976 in respect of Schedules 2, 3 and 4 thereof.

The Borough Council of Neath (Town Centre)(One Way Traffic) Order 1974.

- (ii) The provisions of The West Glamorgan County Council (The Ropewalk and Greenway Road, Neath) (Weight Restriction) Order 1975 made on 14th November 1975 are hereby revoked in so far as they relate to Greenway Road.
- 4. No person shall cause any vehicle, the laden weight of which exceeds 7.5 tonnes to proceed in or along Greenway Road, Neath, except for access to premises in or on the said road.
- 5. No person shall cause or permit any vehicle to enter
  - (a) Orchard Street (lower Orchard Street) from
    St. Davids Street or;
  - (b) Neath Bus Station near its junction with St. Davids Street from Orchard Street; or
  - (c) Neath Bus Station at its southern end from Victoria Gardens (Library Road Junction).
- 6. Save as provided in Articles 7 and 8 of this Order no person shall, except upon the direction of a Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the sides or lengths of road specified in Schedule 1 to this Order.

- 7. Nothing in Article 6 of this Order shall render it unlawful to cause or permit any vehicle to wait on the sides or lengths of road specified therein for so long as may be necessary to enable:-
  - (a) a person to board or alight from the vehicle,
  - (b) goods to be loaded on or unloaded from the vehicle;
  - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
    - (i) building, industrial or demolition operations;
    - (ii) the removal of any obstruction to traffic;

- (iii) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
- 8. Nothing in Article 6 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the sides or lengths of road referred to in the said Article for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same side of the road).
- 9. No person shall cause or permit any vehicle except a public service vehicle to enter the northern entrance of the Neath Bus Station at its junction with St. David's Street.
- 10. Save for public service vehicles, no person shall except on the direction of a Police Constable in uniform or of a traffic warden cause any vehicle to wait or to be loaded or unloaded at any time on the sides or lengths of road specified in Schedule 2 to this Order.
- 11. No person shall except on the direction of a Police Constable in uniform or of a traffic warden cause any vehicle to wait or to be loaded or unloaded at any time other than between 8.00 a.m. and 12 noon on Sunday on the sides or lengths of road specified in Schedule 3 to this Order.

12. Nothing in Article 11 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of road specified therein for ao long as may be necessary to enable the vehicle to wait in Orchard Street, Neath, for so long as such waiting is reasonably necessary in connection with any wedding or funeral service being conducted in the adjoining Baptist Church at 22 Orchard Street, Neath.

# SCHEDULE 1

### No Waiting at Any Time Orchard Street (West Side)

From the northern kerbline of Queen Street for a distance of 50 metres in a northerly direction.

### SCHEDULE 2

# No Waiting, No Loading or Unloading At Any Time Orchard Street (East Side)

From a point opposite the northern kerbline of Queen Street for a distance of 70 metres approximately in a northerly direction/

### SCHEDULE 3

No Waiting, No Loading or Unloading At Any Time Except between 8.00 a.m. and 12 Noon on Sunday Orchard Street (West Side).

From a point 50 metres approximately north of the northern kerbline of Queen Street for a distance of 40 metres approximately in a northerly direction.
