

WEST GLAMORGAN COUNTY COUNCIL(ORCHARD STREET, NEATH)(PROHIBITION OF WAITING, LOADING AND UNLOADING ORDER) 1986

The Council of the County of West Glamorgan (hereinafter referred to as "the Council") in exercise of their powers under Section 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984, (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order.

1. This Order shall come into operation on the ~~26th~~ day of ~~MAY~~ 1986 and may be cited as the "West Glamorgan County Council (Orchard Street, Neath) (Prohibition of Waiting Loading and Unloading) Order 1986".
2. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. Save as provided in Article 5 this Order no person shall, except upon the direction or with permission of a Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait or to be loaded or unloaded at any time on the length or side of road specified in the Schedule to this Order.
5. (1) Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the length or side of road referred to therein for so long as may be necessary to enable -
  - (a) a person to board or alight from the vehicle;
  - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
    - i) building, industrial or demolition operations;
    - ii) the removal of any obstruction to traffic;
    - iii) the maintenance, improvement or reconstruction of the side of road; or
    - iv) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984 or

- (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
  - (d) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
  - (e) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
  - (f) the vehicle to wait at or near to any premises situated on or adjacent to the said side or any of the said lengths of road for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral; or
  - (g) the vehicle to be used for fire brigade, ambulance or police purposes.
6. The provisions of the West Glamorgan County Council (Orchard Street, Queen Street, Green Street, Wind Street and New Street, Neath) (Limited Access) Order 1976 made on 19 July 1976 are hereby revoked in so far as they relate to the side or length of road as set out in the Schedule to this Order.
7. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1967 or by or under any other enactment.

SCHEDULE

No Waiting, Loading or Unloading 'At Any Time'  
Orchard Street (north side)

Between points 15 metres and 25 metres east of its junction with the eastern kerbline of Wind Street.
