- 1. No person shall cause any vehicle to be driven in that length of Park Lane, Blaengwynfi specified in the Schedule to this Order.
- 2. This Order shall come into operation on the 20H day of June 1983, and may be cited as the "West Glamorgan County Council (Park Lane, Blaengwynfi) (Prohibition of Driving) Order, 1983).




