THE TRUNK ROAD (A48) (BAGLAN-BRITON FERRY, WEST GLAMORGAN)
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 1986

COMING INTO OPERATION

5th October 1986

WHEREAS the Secretary of State for Wales, being the highway authority for the relevant length of the London-Fishguard Trunk Road (A48) (hereinafter referred to as "the trunk road"), is satisfied that traffic in a specified length of the trunk road should be prohibited by reason of works to be executed thereon:-

NOW THEREFORE, the Secretary of State in exercise of the powers conferred upon him by Section 14(1) of the Road Traffic Regulation Act 1984(a), and of all other enabling powers, hereby makes the following Order:-

1. This Order shall come into operation on the 5th October 1986 and may be cited as the Trunk Road (A48) (Baglan-Briton Ferry, West Glamorgan) (Temporary Prohibition of Traffic) Order 1986.
2. Subject to the provisions of Article 3 of this Order, no person shall from 5th October 1986 until the said works are completed, cause or permit any vehicle to proceed in that length of the trunk road specified in the Schedule to this Order.
3. The provisions of Article 2 of this Order shall only apply during such times as shall be indicated by traffic signs.

SCHEDULE

That length of the trunk road at Baglan in the County of West Glamorgan which extends from a point 30 metres south of the centre of Baglan Lodge Footbridge in a general north-westerly direction to a point 30 metres north of the centre of .. Swan Road Footbridge.



THE TRUNK ROAD (A48) (BAGLAN-BRITON FERRY, WEST GLAMORGAN)

(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 1986

NOTICE IS HEREBY GIVEN that by reason of works being executed on the London-Flatguard Trunk Road (A48) (hereinafter referred to as "the trunk road") the Secretary of State for Wales has made an Order under Section 14 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to close that length of the trunk road specified in the Schedule to this Notice. It is expected that the closure will be operative only between the hours of midnight and 8 am on 5th, 12th and 19th October 1986.

The alternative route for southbound traffic will be via Old Road, Willow Way, Glan Hafre and Sunny Mount and vice versa for northbound traffic.

The alternative route for traffic requiring access to premises adjacent to the eastbound carriageway of the trunk road will be via Swan Street; and via Pinewood Terrace for traffic requiring access to premises adjacent to the westbound carriageway.

That length of the trunk road at Baglan in the County of West Glamorgan which extends from a point 30 metres south of the centre of Baglan Lodge Footbridge in a general north-westerly direction to a point 30 metres north of the centre of Swan Road Footbridge.
