

THE WEST GLAMORGAN COUNTY COUNCIL  
(ACCESS ROAD TO DISABLED CENTRE AND COMMERCIAL ROAD,  
TAIBACH, PORT TALBOT) (PROHIBITION OF  
WAITING, LOADING AND UNLOADING) ORDER 1983

The West Glamorgan County Council in exercise of their powers under Section 1(1), (2), (3) and 84D(1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, Schedule 6 of the Road Traffic Act 1974 and Schedule 7 of the Local Government Planning and Land Act 1980 (which said Act of 1967 as so amended is hereinafter referred to as the "Act of 1967") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Section 84(C)1 of the Act of 1967, hereby make the following Order:-

1. This Order shall come into operation on the 13<sup>th</sup> day of February 1984 and may be cited as the "West Glamorgan County Council (Access road to Disabled Road Centre and Commercial Road, Taibach, Port Talbot) (Prohibition of Waiting, Loading and Unloading) Order 1983.
2. Save as provided in Article 3 of this Order no person shall, except upon the direction of a Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait, or to be loaded or unloaded on any day between the hours of 9.00 a.m. and 9.00 p.m. on the lengths of roads specified in the Schedule to this Order.
3. Nothing in Article 2 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of road specified therein if it cannot conveniently be used for such purposes in any other road, to be used in connection with any the following purposes namely:-
  - (a) building, industrial or demolition operations;
  - (b) the removal of any obstruction to traffic;
  - (c) the maintenance, improvement or reconstruction of the side of road;
  - (d) the laying, erection, alteration or repair in or on land adjacent to the said side of road or any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878; or
  - (e) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;

- (f) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953.
  - (g) the vehicle to be used for police, fire brigade or ambulance purposes.
4. The Interpretation Act 1978 shall apply to the Order as it applies to an Act of Parliament.

South East Side


From the northern kerbline of Commercial Road for a distance of 10 metres in a north easterly direction.

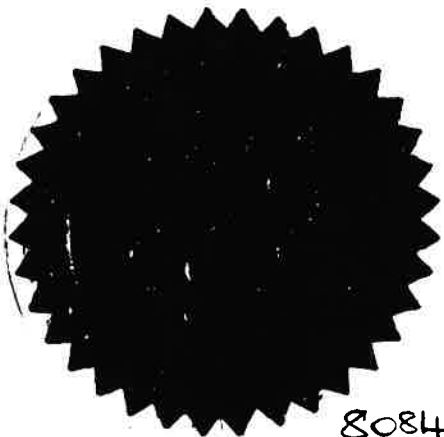
Commercial Road (North Side)
