# NORTH EAST DERBYSHIRE DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) (AMENDMENT NO.1) ORDER 2017

North East Derbyshire District Council ("the Council") in exercise of its powers under Section 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the 1984 Act") and of all other enabling powers, with the consent of the Derbyshire County Council in accordance with section 39(3) of the 1984 Act and after consultation with the Chief Constable of Derbyshire Constabulary in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

#### PART 1 GENERAL

#### Commencement and Citation

1. This Order is supplemental to the Principal Order

2. This Order shall come into operation on the day of October 2017 and may be cited as the North East Derbyshire District Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) (Amendment No.1) Order 2017.

#### Interpretation

3. In this Order, except where the context otherwise requires, the following expressions have the meaning respectively assigned to them:

"the Principal Order" means the North East Derbyshire District Council (Off- Street Parking Places) (Civil Enforcement and Consolidation) Order 2009.

## PART 2 AMENDMENTS TO THE PRINCIPAL ORDER

- 4. The Principal Order shall have effect as though:
  - (a) The following parking places, namely:
    - Manor Offices Car Park Dronfield (SK34977848)
       did not form part of the Principal Order, its schedule or the plans attached to it.
  - (b) That the plans attached to this order marked:
    - "Eckington Pool Car Park, Gosber Street, Eckington (SK42967922)" be substituted for the plan marked "Eckington Pool Car Park, Gosber Street Eckington (SK42967922)" attached to the Principal Order.
    - "Eldon Street Car Park, Clay Cross (SK39206356)" be substituted for the plan marked
       "Eldon Street Car Park, Clay Cross (SK39206356)" attached to the Principal Order.

- (c) The parking place specified in Schedule 1 to this Order, namely Bridge Street Car Park, Clay Cross (SK39366356) shown on the plan attached to this Order. Shall from 1st day of October 2017 be subject to the provisions contained in the Principal Order and its schedules.
- (d) That the postal address of North East Derbyshire District Council as shown in the Principal Order be now known as District Council Offices, 2013 Mill Lane, Wingerworth, Chesterfield, Derbyshire S42 6NG.
- All other provisions of the Principal Order shall remain in full force and effect. 5.




The Parking Place under this Order is listed below and shown edged in red on corresponding attached plan.


