SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

1. THIS Order may be cited as "The Surrey County (Various Roads in Waverley) (Residents' Only On-Street Parking Places) (No. 2) Order 2012 (Amendment No. 4) Order 2018" and shall come into operation on 16 July 2018_____
2.
 - (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Waverley) (Residents' Only On-Street Parking Places) (No. 2) Order 2012_____
 - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment_____
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order_____
3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though:-
 - (a) For the First Part of the First Schedule to the Principal Order there was substituted the First Schedule to this Order_____
 - (b) For the Second Schedule to the Principal Order there was substituted the Schedule set out in the Schedule to this Order_____

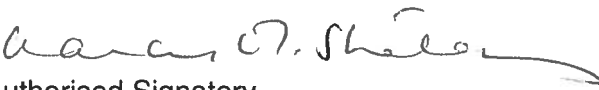
