SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

1 THIS Order may be cited as "The Surrey County Council (Amendment and Roads in Farnham) (Prohibition and Waiting and Driving) Order 1976 (Amendment No. 1) Order 2021" and shall come into operation on 7 June 2021_____

2 (1) In this Order "the Principal Order" means The Surrey County Council (Amendment and Roads in Farnham) (Prohibition and Waiting and Driving) Order 1976 _____

(2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment_____

(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though the item labelled "RED LION LANE" in the Second Schedule to the Principal Order was omitted in its entirety_____
