THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2(1) to 3 and 4 and 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

THIS Order may be cited as "The Surrey County Council (Farnham Railway Station Controlled Parking Zone) (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2007) (Amendment No. 3) Order 2011" and shall come into operation on 1 April 2011

Interpretation

- 2 (1) In this Order the expression "the Order of 2007" means The Surrey County Council Farnham Railway Station Controlled Parking Zone (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2007
 - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bye-law rule regulation scheme or other instrument having effect by virtue of an enactment
 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2007 shall have the same meaning as in that Order

Amendment of the Order of 2007

- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of 2007 shall have effect as though -
- (a) in paragraph (2) of Article 33 for the words "PROVIDED THAT in this paragraph "specified proportion" means such proportion applicable to all cases as may be determined by the Local Authorities acting through the Joint Committee" there were substituted the words "PROVIDED THAT in this paragraph "specified proportion" means such proportion applicable to all cases as may be determined by the Council"
- (b) in paragraph (4) of Article 29(A) in the seventh line thereof for the words "may exceed thirty in each calendar with" there were substituted the words "may exceed thirty in each calendar year with"
- (c) for the Second Schedule to that Order there was substituted the Second Schedule set out in The Schedule to this Order
