

**THE KENT COUNTY COUNCIL (VARIOUS ROADS, BOROUGH OF SWALE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT No.3) ORDER 2019**

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:-

A - This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.3 Order 2019" ('this Order') and shall come into force on the 24th day of June, 2019.

B - The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the Order') shall have effect as though -

In the Schedules to the Order

FIRST SCHEDULE

Roads in Sittingbourne

Access Road Between Cole Close and Tylden Gardens

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

ACCESS ROAD BETWEEN COLE CLOSE AND TYLDEN GARDENS

On both sides, from the northern kerbline of Seddingbourne Way for a distance of 6 metres in a northerly direction.

Cole Close

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

COLE CLOSE On both sides, from the northern kerbline of Seddingbourne Way for a distance of 6 metres in a northerly direction.

Eurolink Way

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in place of the existing entry:

EUROLINK WAY (1) On the service Road to the east of the Homebase Store, on both sides of the

road from the Junction of Eurolink Way for a distance of 55 metres in a northerly direction;

(2) On the northern side, from a point 25 metres west of the western kerbline of Robertson Drive to a point 25 metres east of the eastern kerbline of Robertson Drive.

Rapson End

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

RAPSON END On both sides, from the southern kerbline of Seddingbourne Way for a distance of 10 metres in a southerly direction.

Robertson Drive

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

ROBERTSON DRIVE (1) On the western side

(a) from the northern kerbline of Eurolink Way for a distance of 28 metres in a northerly direction;

(b) from the southern kerbline of Seddingbourne Way for a distance of 8 metres in a southerly direction;

(2) On the eastern side

(a) from the northern kerbline of Eurolink Way for a distance of 29 metres in a northerly direction;

(b) from the southern kerbline of Seddingbourne Way for a distance of 8 metres in a southerly direction.

Seddingbourne Way

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

SEDDINGBOURNE WAY

(1) On the northern side

(a) from the western kerbline of Crown Quay Lane for a distance of 17 metres in a westerly direction;

(b) from the eastern kerbline of Cole Close for a distance of 6 metres in an easterly direction;

(c) from the western kerbline of Cole Close for a distance of 6 metres in a westerly direction;

(d) from the eastern kerbline of the access road between Cole Close and Tylden Gardens for a distance of 6 metres in an easterly direction;

(e) from the western kerbline of the access road between Cole Close and Tylden Gardens to the eastern kerbline of Tylden Gardens;

(f) from the western kerbline of Tylden Gardens for a distance of 8 metres in a westerly direction.

(2) On the southern side

(a) from the western kerbline of Crown Quay Lane for a distance of 21 metres in a westerly direction;

(b) from the eastern kerbline of Rapson End for a distance of 6 metres in an easterly direction;

(c) from the western kerbline of Rapson End for a distance of 6 metres in a westerly direction;

(d) from a point 6 metres east of the eastern kerbline of the access road between Cole Close and Tylden Gardens to the eastern kerbline of Robertson Drive;

(e) from the western kerbline of Robertson Drive to a point 8 metres west of the western kerbline of Tylden Gardens.

Tylden Gardens

The following shall be inserted in the First Schedule (*No Waiting At Any Time*) in the correct alphabetical sequence:

TYLDEN GARDENS On both sides of the road, from the northern kerbline of Seddingbourne Way for a distance of 8 metres in a northerly direction.

The following shall be inserted in the Third Schedule (*Daytime Waiting Restrictions*) in the correct alphabetical sequence:
