
THE KENT COUNTY COUNCIL
(VARIOUS ROADS, BOROUGH OF SWALE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(AMENDMENT No.44) ORDER 2023

The Kent County Council, acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, ('the Act') and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

A - This Order may be cited as "The Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) Amendment No.44 Order 2023" ('this Order') and shall come into force on the 1st day of September 2023.

B - The "Kent County Council (Various Roads, Borough of Swale) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2019" ('the 2019 Order') shall have effect as though -

In the Schedules to the 2019 Order

FIRST SCHEDULE
NO WAITING AT ANY TIME

Roads in Sittingbourne and Milton

The following shall be inserted in the First Schedule of the 2019 Order in place of the existing entry:

CHALKWELL ROAD (1) On the eastern side

(a) from the Junction with London Road a point in line with the southern boundary of 144 Chalkwell Road;

(b) from a point 7 metres north of the boundary of 128/130 Chalkwell Road for a distance of 28 metres in a northerly direction.

(2) On the western side

(a) from the Junction with London Road to the Junction with Wellwinch Road;

(b) from the northern kerbline of Springfield Road for a distance of 10 metres in a northerly direction;

(c) from the southern kerbline of Springfield Road for a distance of 10 metres in a southerly direction.

(3) On the north-western side

(a) between points 10 metres north-east and 10 metres south-west of the Junction with Hythe Road;

(b) from a point in line with the northeast building line of 47 Chalkwell Road to a point in line with the southwest building line of 41 Chalkwell Road;

(c) from a point 4 metres south-west of the north-eastern boundary of 1 Alexander Court for a distance of 18 metres in a north-easterly direction.

(4) On the south-eastern side from a point in line with the boundary of 20/22 Chalkwell Road for a distance of 20 metres in a north-easterly direction.

The following shall be inserted in the First Schedule of the 2019 Order in the correct alphabetical sequence:

RECREATION WAY (1) On the northern side, between points 9 metres west and 11 metres east of the boundary of 73/75 Recreation Way.

(2) On the western side, from a point 6 metres south of the northern building line of 69 Recreation Way, north to a point in line with the southern kerbline of Recreation Way.

(3) On the eastern and southern side, from a point 6 metres south of the northern building line of 69 Recreation Way to a point 1 metre east of the boundary of 75/77 Recreation Way.

The following shall be inserted in the First Schedule of the 2019 Order in the correct alphabetical sequence:

ROMNEY COURT On both sides from the Junction with Chalkwell Road for a distance of 7 metres in a north-westerly direction.

**SEVENTH SCHEDULE
PARKING PLACES FOR DISABLED PERSONS VEHICLES**

The following shall be deleted from the Seventh Schedule of the 2019 Order:

Roads in Sittingbourne and Milton	
CHALKWELL ROAD	Across the frontage of 34 Chalkwell Road

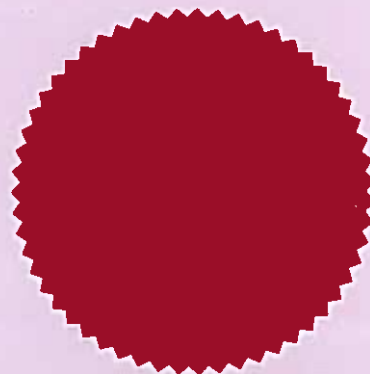
