**Kent County Council (Various Roads, Tonbridge) (Variation of Tonbridge and
Malling Borough 1986 Consolidated Traffic Order) (Variation No 42)
Road Traffic Regulation Act 1984 (as amended)**

ON-STREET PARKING PLACE ORDER

The Kent County Council in exercise of powers under Sections 32, 35 and 124(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act (as amended) (hereinafter referred to as the Act of 1984) and of all other enabling powers after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 of the Act 1984 hereby makes the following Order: -

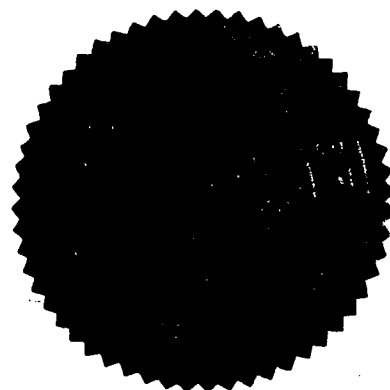
1. This Order shall come into operation on 31st July 1998 and may be cited as "The Kent County Council (Various Roads, Tonbridge) (Variation of Tonbridge and Malling Borough 1986 Consolidated Traffic Order) (Variation No 42) Order 1998"
2. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Except where the context otherwise admits any reference to a Schedule is a reference to a Schedule to this Order.
4. In this Order the expression "Order of 1986" means the "Borough of Tonbridge and Malling (Consolidation of Traffic Orders) (Various Roads, Tonbridge) Order 1986"
5. The Order of 1986 shall have effect as though the length of road specified in schedule 1 to this Order was included in the Order of 1986.
6. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 as amended as aforesaid or by or under any other enactment's.
