KENT COUNTY COUNCIL (VARIOUS ROADS, TONBRIDGE) (VARIATION OF TONBRIDGE AND MALLING BOROUGH 1986 CONSOLIDATED TRAFFIC ORDER) (VARIATION NO 45) ORDER 1999

The Kent County Council in exercise of its powers under Sections 1(1),(2),(3), 45,124(1) and Part IV of schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Police pursuant to Part III of Schedule to the Act of 1984 do hereby make the following Order:-

- 1. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies to an Act of Parliament.
- 2. In this Order the expression "Order of 1986 "means "The Borough of Tonbridge and Malling (Consolidation of Traffic Orders) (Various Roads, Tonbridge) Order 1986"
- 3. This Order shall come into operation on 10th May 1999 and shallbe cited as "The Kent County Council (Various Roads, Tonbridge) (Variation of Tonbridge and Malling Borough 1986 Consolidated Traffic Order) (Variation No. 45) Order 1999".
- 4. Except where the context otherwise admits any reference to a schedule is a reference to a schedule to this order.
- 5. The Order of 1986 is hereby varied as follows;
 - (a) The lengths of street specified in Part 1 of the Schedule to this Order shall be deleted from the Order of 1986
 - (b) The lengths of street specified in Part 2 of the Schedule to this Order shall be added to Part 1 of the First Schedule to the Order of 1986
- PLACE SAME SET TO BE TO BE SET TO BE
- (c) The lengths of street specified in Part 3 of the Schedule to this Order shall be added to the Fifth Schedule to the Order of 1986
- (d) The lengths of street specified in Part 4 of the Schedule to this Order shall be added to Part 2 of the Sixth Schedule to the Order of 1986
- (e) The following definition shall be added to Part A of the Order of 1986;
 - " The term School Keep Clear Marking shall mean a marking on the carriageway outside a school entrance which should be kept clear of stationery vehicles "
- (f) The following shall be added to Part B of the Order of 1986

SCHOOL KEEP CLEAR MARKINGS

Save as provided by Articles 28, 29, 35 (a),(d),(f) and (g) in Part G no person except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden shall cause or permit a vehicle to wait in any length of street specified in the Ninth Schedule within such periods as maybe specified on any notices erected in those lengths of street for the purpose of indicating the days/hours during which waiting is prohibited within such lengths of street

- (g) The Schedule and the lengths of street specified in Part 5 of the Schedule to this Order shall be added to the Order of 1986
- (h) The lengths of street specified in Part 6 of the Schedule to this Order shall be added to the Second Schedule of the Order of 1986
- 6. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act of 1984 as aforesaid or by any other enactments.
