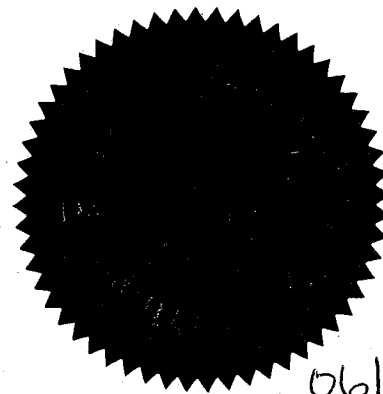

**THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING)**  
**(WIGAN ROADS NO.2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004**  
**(AMENDMENT NO. 7) ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads No.2) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 7) Order 2006 and shall come into operation on 23<sup>rd</sup> January 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No.2)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows: -
  - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order: -
