## THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING) (VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO 5) ORDER 2006
