**THE WIGAN BOROUGH (DECriminalISATION OF PARKING)**  
**(VARIOUS ROADS IN WIGAN BOROUGH)**  
**(TRAFFIC REGULATION CONSOLIDATION) ORDER 2004**  
**(AMENDMENT NO.33) ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 33) Order 2006 and shall come into operation on 12<sup>th</sup> June 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
  - (a) In relation to Schedule One, the following entry shall be added to Schedule One to the Order:-

Tyldesley Road, Atherton	North East	A point 25 metres north west of its southern junction With Tyldesley Old Road	Its southern junction with Tyldesley Old Road

- (b) In relation to Schedule Two, the following entry shall be deleted from Schedule Two to the Order:-

Tyldesley Road, Atherton	North East	A point 14 metres north west of its southern junction with Tyldesley Old Road	A point 26 metres south east of its southern junction with Tyldesley Old Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.00am – 7.00pm
--------------------------	------------	---	---	---

- (c) In relation to Schedule Two, the following entry shall be added to Schedule Two to the Order:-

Tyldesley Road, Atherton	North East	Its southern junction with Tyldesley Old Road	A point 26 metres south east of its southern junction with Tyldesley Old Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.00am – 7.00pm
--------------------------	------------	---	---	---

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 shall remain in force.
