## THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING) (WIGAN) ROADS NO.2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT No.4.) ORDER 2006
