

**WIGAN BOROUGH COUNCIL**  
**THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING) (WIGAN ROADS NO.2)**  
**(TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT No 4)**  
**ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and of all other powers enabling it in that behalf hereby makes the following Order:-

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No.2) (Traffic Regulation Consolidation) Order 2004 (Amendment No.4) Order 2006 and shall come into operation on 7<sup>th</sup> August 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

- (a) In relation to Schedule One the following entry shall be added to Schedule One to the Order.

Park Crescent, Wigan	West	A point 67 metres south west of Park Road, Wigan	Its cul-de-sac end

- (b) In relation to Schedule Seven, the following entry shall be deleted from Schedule Seven to the Order:

Park Crescent, Wigan	Both	A point 9 metres south west of Park Road, Wigan	Its cul-de-sac end	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00a.m. – 5.00 p.m.

- (c) In relation to Schedule Seven, the following entries shall be added to Schedule Seven to the Order:

Park Crescent, Wigan	West	A point 9 metres south west of Park Road, Wigan	A distance of 58 metres in a south westerly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00a.m. – 5.00p.m.

Park Crescent, Wigan	East	A point 9 metres south west of Park Road, Wigan	Its cul-de-sac end.	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00a.m. – 5.00p.m.

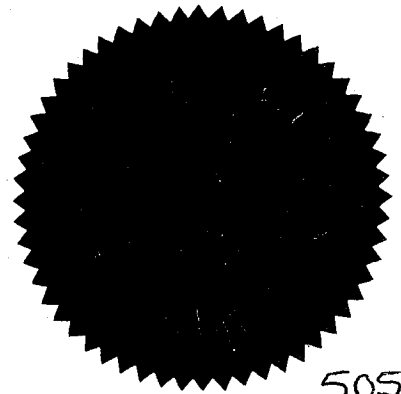
