

THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING)
(WIGAN ROADS NO.2) (TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004 (AMENDMENT NO.1) ORDER 2006

The Wigan Borough Council, in exercise of its powers under Sections 1, 45, 46, 47 and 49 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and of all other powers enabling it in that behalf hereby makes the following Order:-

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No.2) (Traffic Regulation Consolidation) Order 2004 (Amendment No.1) Order 2006 and shall come into operation on 11th December 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No.2) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

(a) In relation to Schedule Two, the following entry shall be deleted from Schedule Two to the Order:-

Danesway, Wigan	Both	Its junction with Mesnes Road	For a distance of 20 metres in a westerly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00 am – 5.00 pm

(b) In relation to Schedule Two, the following entries shall be added to Schedule Two to the Order:-

Danesway, Wigan	North	Its junction with Mesnes Road	For a distance of 15 metres in a westerly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00 am – 5.00 pm

Danesway, Wigan	South	Its junction with Mesnes Road	For a distance of 20 metres in a westerly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00 am – 5.00 pm

(c) In relation to Schedule Seven, the following entry shall be deleted from Schedule Seven to the Order:-

Danesway, Wigan	North	A point 10 metres east of Coniston Avenue	A point 20 metres west of Mesnes Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00 am – 5.00 pm

(d) In relation to Schedule Seven the following entry shall be added to Schedule Seven to the Order:-

Danesway, Wigan	North	A point 10 metres east of Coniston Avenue	A point 15 metres west of Mesnes Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am to 5.00pm

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No.2) (Traffic Regulation Consolidation) Order 2004 shall remain in force.
