**THE WIGAN BOROUGH(DECriminalISATION OF PARKING)**  
**(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)**  
**ORDER 2004 (AMENDMENT NO.59) ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.59) Order 2006 and shall come into operation on 4<sup>th</sup> December 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

(a) In relation to Schedule One, the following entry shall be deleted from Schedule One to the Order:-

Cale Lane Aspull	Both	Its junction with Wigan Road.	A point 20 metres south east of its junction with Longfield Street.

(b) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Cale Lane, Aspull	North	Its junction with Wigan Road.	A point 10 metres south east of its junction with Bolney Street.
----------------------	-------	----------------------------------	---

Cale Lane, Aspull	South	Its junction with Wigan Road.	A point 20 metres south east of its junction with Longfield Street.
----------------------	-------	----------------------------------	---

Bolney Street, Aspull.	North	Its junction with Cale Lane.	For a distance of 19 metres in a north easterly direction.
---------------------------	-------	---------------------------------	--

Bolney Street, Aspull	South	Its junction with Cale Lane.	For a distance of 10 metres in a north easterly direction.
--------------------------	-------	---------------------------------	--

- (c) In relation to Schedule Nine, the following entry shall be added to Schedule Nine to the Order:-

Cale Lane Aspull	South	A point 20 metres south east of its junction with Longfield Street.	For a distance of 37.6 metres in a south easterly direction.

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 shall remain in force.
