(AMENDMENT NO. 137) ORDER 2008**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order-

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.137) Order 2008 and shall come into operation on 5th January 2009.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

- (a) In relation to Schedule One the following entries shall be deleted from Schedule One to the Order:-

Market Place, Standish	North East	A point 15 metres south east of the projected north western kerbline of Cross Street	Its junction with Church Street

Market Place, Standish	South	Its junction with Church Street	A point 10 metres north west of its junction with Cross Street

- (b) In relation to Schedule One the following entries shall be added to Schedule One to the Order:-

Market Place, Standish	North	Its junction with Market Street	For a distance of 10 metres in an easterly direction

- (e) In relation to Schedule Four the following entry shall be deleted from Schedule Four to the Order:-

Market Place, Standish	North East	A point 2 metres north west of the projected north western kerb line of Cross Street	For a distance of 17 metres in a south easterly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am – 7.00pm

- (f) In relation to Schedule Four the following entry shall be added to Schedule Four to the Order:-

Market Place, Standish	North	A point 49 metres east of its junction with Market Street	A point 62 metres east of its junction with Market Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am – 6.00pm

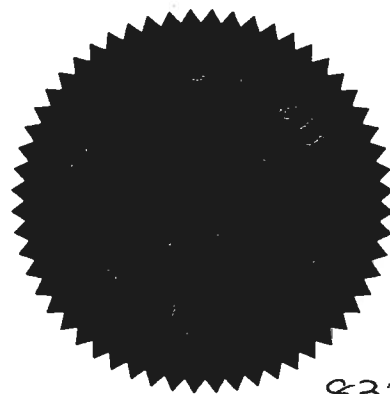
