**WIGAN BOROUGH(DECRIMINALISATION OF PARKING)  
(WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004  
(AMENDMENT NO. 53) ORDER 2011**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 53) Order 2011 and shall come into operation on 25<sup>th</sup> February 2011.
2. Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule Six, On Street Parking Places, the following entry shall be deleted from Schedule Six to the Order:-

Wigan Lane, Wigan	West	A point 165 metres north of its junction with Kingsmede	A point 178 metres north of its junction with Kingsmede	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00 am to 5.00 pm	<p>During the charging hours an initial charge of</p> <p>(a) 60 pence per half hour</p> <p>(b) 80 pence per hour</p> <p>or any part thereof subject to a maximum stay of three hours after which time the excess charges shall apply</p>

- (b) In relation to Schedule Seven, Privileged Parking Places, the following entry shall be deleted from Schedule Seven to the Order:-

Wigan Lane, Wigan	West	A point 178 metres north of its junction with Kingsmede	A point 197 metres north of its junction with Kingsmede	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00 am to 5.00 pm


- (c) In relation to Schedule Seven, Privileged Parking Places, the following entry shall be added to Schedule Seven to the Order:-

Wigan Lane, Wigan	West	A point 165 metres north of its junction with Kingsmede	A point 197 metres north of its junction with Kingsmede	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00 a.m. to 5.00 p.m.

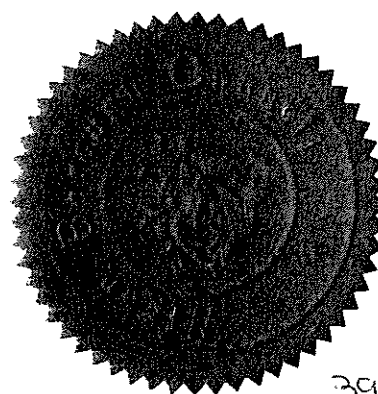
