CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 199) ORDER 2011**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 199) Order 2011 and shall come into operation on 9<sup>th</sup> January 2012
2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

- (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be deleted from Schedule One to the Order:-

Road	Side	From	To
Thomas Street, Hindley Green	Both	its junction with Leigh Road	a distance of 10 metres in a westerly direction

- (b) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be added to Schedule One to the Order:-

Road	Side	From	To
Thomas Street, Hindley Green	Both	its junction with Leigh Road	a distance of 6 metres in a westerly direction

- (c) In relation to Schedule 2, Restriction of Waiting, the following entry shall be added to Schedule 2 to the Order

Road	Side	From	To	Period of Operation
Thomas Street, Hindley Green	South	A point 6 metres west of Leigh Road	A point 30 metres west of Leigh Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.00 am to 7.00 pm

- (d) In relation to Schedule 4, Prohibition/Restriction of Loading/Unloading, the following entry shall be deleted from Schedule 4 to the Order

Road	Side	From	To	Period of Operation
Thomas Street, Hindley Green	Both	Its junction with Leigh Road	For a distance of 10 metres in a westerly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.00 am to 7.00 pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.

2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

- (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be deleted from Schedule One to the Order:-

Road	Side	From	To
Thomas Street, Hindley Green	Both	its junction with Leigh Road	a distance of 10 metres in a westerly direction

- (b) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be added to Schedule One to the Order:-

Road	Side	From	To
Thomas Street, Hindley Green	Both	its junction with Leigh Road	a distance of 6 metres in a westerly direction

- (c) In relation to Schedule 2, Restriction of Waiting, the following entry shall be added to Schedule 2 to the Order

Road	Side	From	To	Period of Operation
Thomas Street, Hindley Green	South	A point 6 metres west of Leigh Road	A point 30 metres west of Leigh Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.00 am to 7.00 pm

- (d) In relation to Schedule 4, Prohibition/Restriction of Loading/Unloading, the following entry shall be deleted from Schedule 4 to the Order

Road	Side	From	To	Period of Operation
Thomas Street, Hindley Green	Both	Its junction with Leigh Road	For a distance of 10 metres in a westerly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.00 am to 7.00 pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
