**WIGAN BOROUGH (DECRIMINALISATION OF PARKING)  
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004  
(AMENDMENT NO.62) ORDER 2012**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 62) Order 2012 and shall come into operation on 6<sup>th</sup> April 2012
2. Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-

- (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be deleted from Schedule One to the Order:-

Road	Side	From	To
Cawdor Street, Leigh	South	For its entire length	

- (b) In relation to Schedule One, Prohibition of Waiting at any time, the following entry shall be added to Schedule One to the Order:-

Road	Side	From	To
Cawdor Street, Leigh	South	A point 8 metres east of its junction with Ellesmere Street	Its westerly cul-de-sac end

- (c) In relation to Schedule Two, Restriction of Waiting, the following entry shall be deleted from Schedule Two to the Order

Road	Side	From	To	Period of Operation
Cawdor Street, Leigh	North	For its entire length		On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00 am to 6.00 pm

- (d) In relation to Schedule Two, Restriction of Waiting, the following entries shall be added to Schedule Two to the Order:-


Road	Side	From	To	Period of Operation
Cawdor Street, Leigh	South	A point 13 metres east of its junction with Ellesmere Street	Its easterly cul-de-sac end	On any Monday, Tuesday, Wednesday, Thursday or Friday 8.00 am to 6.00 pm
Cawdor Street, Leigh	North	For its entire length		On any Monday, Tuesday, Wednesday, Thursday or Friday 8.00 am to 6.00 pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Leigh Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
