WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.230) ORDER 2012

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- 1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.230) Order 2012 and shall come into operation on 13th August 2012.
- 2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be deleted from Schedule One to the Order:-

ROAD	SIDE	FROM	ТО
Green Lane, Standish	both	its junction with School Lane	for a distance of 50 metres in a south easterly direction
Green Lane, Standish	east	a point 40 metres north of Greenland Avenue	a point 10 metres south of Greenland Avenue
Green Lane, Standish	west	a point 52 metres south of its junction with School Lane	for a distance of 79 metres in a southerly direction
Longendale Road, Standish	both	its junction with Green Lane	for a distance of 10 metres in a westerly direction

(b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	ТО
Green Lane	east	its junction with School Lane	a point 10 metres south of its junction with Greenland Avenue

Green Lane	west	its junction with School Lane	from a distance of 79 metres in a southerly direction
Longendale Road	both	its junction with Green Lane	from a distance of 10 metres in a westerly direction
Green Lane	West	a point 10 metres south of its junction with Longendale Road	point 8 metres north of its junction with Longendale Road

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
