WIGAN BOROUGH (DECRIMINALISATION OF PARKING)
(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004
(AMENDMENT NO. 253) ORDER 2013

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 253) Order 2013 and shall come into operation on 5th April 2013.
2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule Two, Restriction of Waiting, the following entries shall be deleted from Schedule Two to the Order:-

Bag Lane, Atherton	West	A point 15 metres north of its junction with Factory Street West	Its junction with Factory Street West	On any Monday, Tuesday, Wednesday, Thursday, Friday and Saturday 8.00am – 6.00pm

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Bag Lane, Atherton	West	A point 10 metres south of its junction with Factory Street West	A point 15 metres south of its junction with Factory Street West	On any Monday, Tuesday, Wednesday, Thursday, Friday and Saturday 8.00am – 6.00pm

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Factory Street West, Atherton	Both	A point 10 metres west of its junction with Bag Lane	A point 15 metres west of its junction with Bag Lane	On any Monday, Tuesday, Wednesday, Thursday, Friday and Saturday 8.00am – 6.00pm

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Factory Street West, Atherton	Both	Its junction with Bag Lane	For a distance of 29 metres in an easterly direction	On any Monday, Tuesday, Wednesday, Thursday, Friday and Saturday 8.00am – 6.00pm

- (b) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Bag Lane Atherton	West	Its junction with Mealhouse Lane	A point 12 metres north of its junction with Mealhouse Lane

ROAD	SIDE	FROM	TO
Bag Lane, Atherton	East	Its junction with Mealhouse Lane	A point 19 metres north of its junction with Mealhouse Lane

ROAD	SIDE	FROM	TO
Bag Lane, Atherton	Both	Its junction with Factory Street West	A point 5 metres north of its junction with Factory Street West

ROAD	SIDE	FROM	TO
Factory Street West, Atherton	Both	Its junction with Bag Lane	A point 10 metres east of its junction with Bag Lane

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
