**(AMENDMENT NO.237) ORDER 2013**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.237) Order 2012 and shall come into operation on Tuesday 3<sup>rd</sup> December 2013.
2. Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One of the Order:-


ROAD	SIDE	FROM	TO
Preston Road, Standish	West	A point 26 metres north of its junction with Kenyon Road	A point 15 metres south of its junction with Kenyon Road
Kenyon Road, Standish	Both	Its junction with Preston Road	For a distance of 23 metres in a westerly direction

- (b) In relation to Schedule Two, Restriction of Waiting at any time, the following entries shall be added to Schedule Two to the Order:-

ROAD	SIDE	FROM	TO	PERIOD OF OPERATION
Preston Road, Standish	West	A point 15 metres south of its junction with Kenyon Road	For a distance of 30 metres in a southerly direction	Monday to Friday 8.00am to 5.00pm
Preston Road, Standish	East	A point 26 metres north of its junction with Kenyon Road	A point 15 metres south of its junction with Kenyon Road	Monday to Friday 8:00am – 9:00am and 3:00pm to 4:00pm

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.

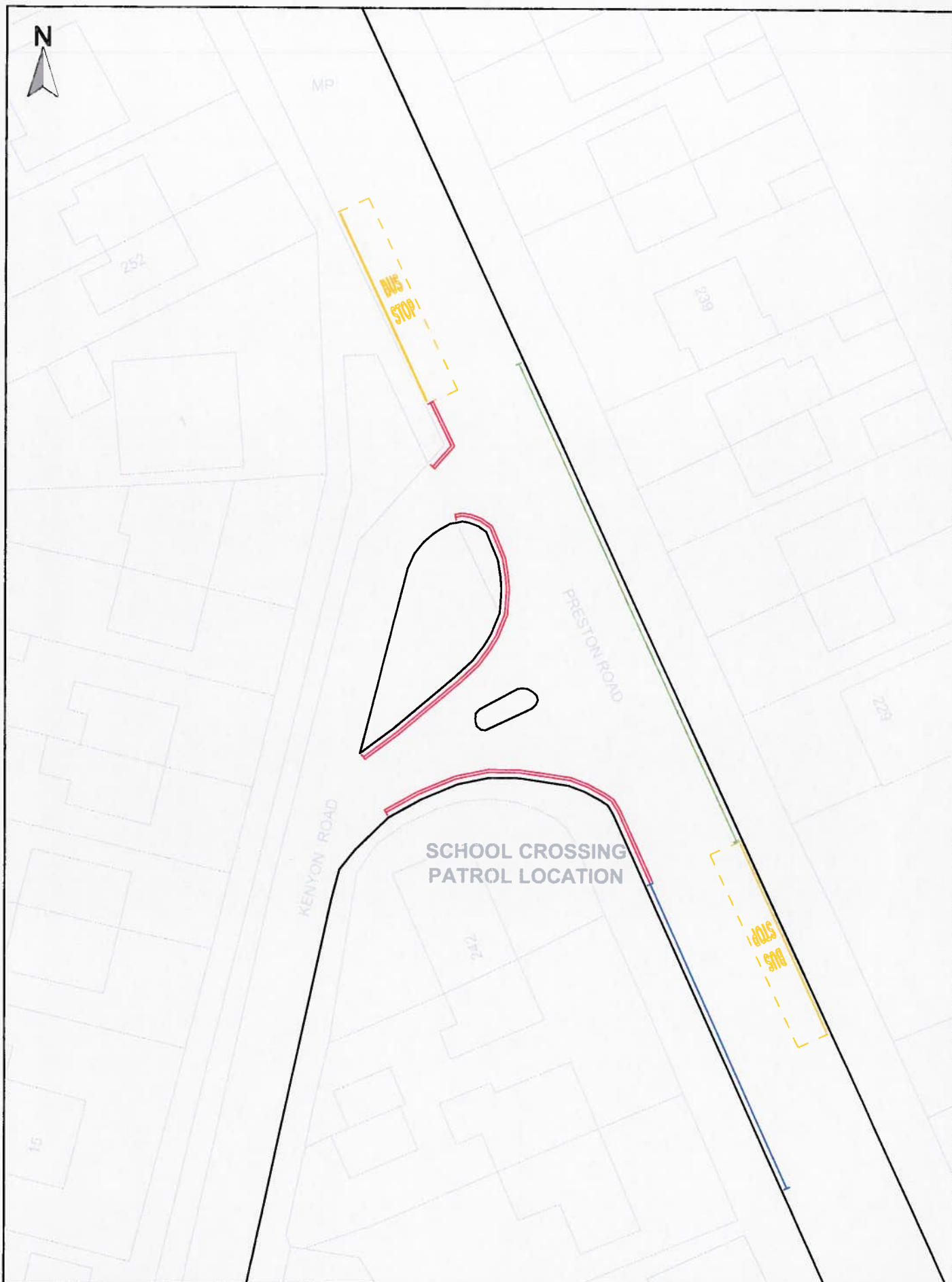
