WIGAN BOROUGH(DECRIMINALISATION OF PARKING)
(WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.80) ORDER 2012

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.80) Order 2012 and shall come into operation on 2nd June 2014.
2. Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

Moss Street, Wigan	Both	its junction with Woodhouse Lane	a distance of 10 metres in a north easterly direction
Woodhouse Lane, Wigan	East	a point 10 metres north west of its junction with Stopforth Street	a point 10 metres south east of its junction with Stopforth Street
Stopforth Street, Wigan	Both	its junction with Woodhouse Lane	a distance of 10 metres in a north eastlerly direction
Woodhouse Lane, Wigan	East	A point 10 metres north west of its junction with Ratcliffe Street	A point 10 metres south east of its junction with Ratcliffe Street
Ratcliffe Street, Wigan	Both	Its junction with Woodhouse Lane	A distance of 10 metres in a north easterly direction
Margaret Street, Wigan	Both	Its junction with Woodhouse Lane	A distance of 10 metres in a north easterly direction
Diggle Street, Wigan	Both	Its junction with Woodhouse Lane	A distance of 10 metres in a north easterly direction
Foster Street, Wigan	Both	Its junction with Woodhouse Lane	A distance of 10 metres in a south westerly direction
Woodhouse Lane, Wigan	West	A point 10 metres north west of its junction with Railway Street	A point 10 metres south east of its junction with Railway Street
Railway Street, Wigan	Both	Its junction with Woodhouse Lane	A distance of 10 metres in a south westerly direction
Railway Street, Wigan	West	A point 12 metres north east of its junction Knightshill Crescent and Meadow Street	A point 10 metres south west of its junction Knightshill Crescent and Meadow Street
Railway Street, Wigan	East	A point 10 metres north east of its junction	A point 10 metres south west of its junction

Meadow Street, Wigan	Both	Its junction with Railway Street	A distance of 10 metres in a south westerly direction

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
