## THE WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (WIGAN ROADS NO. 2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 50) ORDER 2014

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 50) Order 2014 and shall come into operation on 2<sup>nd</sup> December 2014
- 2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entries shall be added to Schedule One to the Order:-

| Andover Crescent,<br>Winstaniey  | Both | Its junction with Tan<br>House Drive                             | A point 10 metres east of Tan House Drive                              |

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
